BE it enacted:—

Short title.

1. This Law may be cited as the Imperial Defence (Cyprus Contribution) Law, 1927.

Annual pay-

2. The sum of ten thousand pounds shall be paid yearly to the Imperial Government as the contribution of the Colony of Cyprus toward the cost of Imperial Defence, and such sum shall be permanently charged on the Consolidated Revenue of the Colony.

3. This Law shall come into operation on the first day of January, 1928.

A.D. 1927. TO AMEND THE LAW RELATING TO THE PUBLIC OFFICERS'
17 of 1927. GUARANTEE FUND.

BE it enacted:—

Short title.

1. This Law may be cited as the Public Officers' Guarantee Fund (Amendment) Law, 1927, and shall be read as one with the Public Officers' Guarantee Fund Law, 1896, (hereinafter referred to as the Principal Law), and the Principal Law and this Law may together be cited as the Public Officers' Guarantee Fund Laws, 1896 and 1927.

2. The Principal Law, section 35, is hereby repealed and in place thereof the following section shall have effect:—

35. Where an officer ceases to hold an appointment in the public service of the Colony, in respect of which security is required to be given by him, or dies, the amount appearing in the books of the fund to his credit, as on the 30th of June next following such cesser or death, after taking into account all transactions, and after deducting the proper proportions of the liabilities of the fund for that year, shall be returned by the Directors to him or his representatives; but the Directors, if the state of the fund shall admit, may, before the 30th of June as aforesaid, pay out of the fund to such officer or his representatives, such portion of the amount paid by such officer by way of contribution to the fund, as they may approve.

TO AMEND THE POLICE LAW.

BE it enacted:—

1. This Law may be cited as the Police (Amendment) Law, 1927, and shall be read as one with the Police Law, 1878, (hereinafter referred to as the Principal Law), and the Principal Law and this Law may together be cited as the Police Laws, 1878 and 1927.

Short title.

2. The Principal Law, section 26, is hereby amended by the addition thereto of the following sub-section:—

Amendment of Law 2 of 1878, sec. 26

(6) Provided also that where any Non-commissioned Officer or Private dies while in the service of the Force, it shall be lawful for the Governor in Council to grant to his dependants the gratuity to which such Non-commissioned Officer or Private would have been eligible had he been discharged from the Force on the grounds of illhealth.

For the purpose of this sub-section the term "dependants" means such of the members of the family of a Non-commissioned Officer or Private as were wholly or in part dependent upon the earnings of the Non-commissioned Officer or Private at the time of his death.
