A LAW TO APPROPRIATE A SUM NOT EXCEEDING SEVEN HUNDRED AND NINETY-EIGHT THOUSAND FOUR HUNDRED AND SIXTY-SIX POUNDS TO THE SERVICE OF THE TWELVE MONTHS ENDING THE THIRTY-FIRST DAY OF DECEMBER, IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTY-EIGHT.

WHEREAS it is necessary to make provision for such expenses of the Government of Cyprus for the year ending the thirty-first day of December, 1938, as are not already lawfully provided for or shall not hereafter be provided for by any Law. Preamble.

BE it therefore enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :—

1. This Law may be cited as the Appropriation Law, 1938. Short title.

2. In addition to the sums already lawfully appropriated to the service of the King or which may be hereafter lawfully appropriated thereto, there shall be issued and applied to the service of the twelve months ending the thirty-first day of December, 1938, out of the revenue and other funds of the Colony, any sum not exceeding the sum of Seven Hundred and Ninety-Eight Thousand Four Hundred and Sixty-Six Pounds for defraying the charge of the Government of Cyprus for such period. Appropriation of £798,466.

3. A sum not exceeding the amount set down under each head in the Schedule hereto may be issued and spent in respect of the Establishment or Service specified and referred to therein; provided that the total sum spent on Personal Emoluments during the year, appropriated under this Law, shall not exceed the sum of Two Hundred and Sixty-Eight Thousand Three Hundred and Thirty-Four Pounds. Limitation of the sum to be spent on Personal Emoluments.

4. This Law shall be deemed to have come into operation on the 1st day of January, 1938. Date of coming into operation,
