**THE STATUTE LAWS OF CYPRUS**

**No. 12 OF 1949.**

A LAW TO PROVIDE FOR THE CONTINUANCE OF THE PROVISIONS OF THE CYPRUS CRIMINAL CODE, 1928 TO 1948, BY VIRTUE OF THIS LAW.

**W**HEREAS the reprint of the Laws and the publication of a consolidated edition is under consideration :

AND WHEREAS it is desirable that the provisions of the Cyprus Criminal Code, 1928 to 1948, should be included in the consolidated edition as aforesaid in the form of a Law enacted wholly in the Colony :

BE it therefore enacted by His Excellency the Officer Administering the Government and Commander-in-Chief of the Colony of Cyprus as follows :—

1. This Law may be cited as the Criminal Code Short title.  
(Continuance of Provisions) Law, 1949.

2. The Laws set out in the Schedule to this Law are hereby repealed.

3. Notwithstanding the repeal in section 2 of this Law, the provisions of the Cyprus Criminal Code, 1928 to 1948, shall, by virtue of this Law, continue to have the force of Law as though such provisions were set out in full in this Law.
