THE STATUTE LAWS OF CYPRUS

No. 22 OF 1950.

A LAW TO AMEND THE ELEMENTARY EDUCATION LAWS,
1933 TO 1949.

BE it enacted by His Excellency the Governor and
Commander-in-Chief of the Colony of Cyprus as
follows:—

1. This Law may be cited as the Elementary Education (Amendment) Law, 1950, and shall be read as one with the Elementary Education Laws, 1933 to 1949 (hereinafter referred to as "the principal Law"), and the principal Law and this Law may together be cited as the Elementary Education Laws, 1933 to 1950.

Amendment
of section 16
of the prin-
cipal Law.

2. Section 16 of the principal Law is hereby amended as follows :—

(a) by the deletion therefrom of sub-section (2) and the substitution therefor of the following sub-section :—

“(2) For Moslem schools in any town, there shall be a Town Committee composed of nine duly qualified members of the Turkish Community of the town concerned, having knowledge of, and interest in, elementary education, appointed by the Governor.

The Governor shall appoint a Chairman and a Vice-Chairman from among the members of a Town Committee.”

(b) by the deletion therefrom of sub-section (4), the existing sub-sections (5) and (6) being re-numbered as sub-sections (4) and (5), respectively ;

(c) by the deletion from sub-sections (4) and (5), re-numbered as hereinbefore, of the words “, other than an *ex officio* member,” in each case.

of section 19
of the prin-
cipal Law.

3. Section 19 of the principal Law is hereby amended by the deletion therefrom of the words “, other than an *ex officio* member,”.

Amendment
of section 63
of the prin-
cipal Law.

4. Sub-section (1) of section 63 of the principal Law is hereby amended as follows :—

(a) by the insertion in paragraph (a) thereof (as set out in section 24 of Law 3 of 1944) after the words “ for Orthodox-Christian ” of the words “ and Moslem ” ;

(b) by the deletion therefrom of paragraph (b) and the re-lettering of paragraph (c) as paragraph (b).

Amendment
of section 86
of the prin-
cipal Law.

5. Sub-section (5) of section 86 of the principal Law (as set out in section 7 of Law 27 of 1937) is hereby amended by the insertion therein after the words “ Orthodox-Christian ” of the words “ or Moslem ”.
